- Within the breakfast cereals industry, China is the leading country among the top 5 emerging nations, with market revenues of \$2,797.3 million in 2021. This was followed by Mexico and India with a value of \$2,307.2 and \$630.6 million, respectively.
- China is expected to lead the breakfast cereals industry in the top five emerging nations, with a value of \$3,349.7 million in 2026, followed by Mexico and India with expected values of \$3,048.7 and \$1,124.4 million, respectively.
