- The Australian Savory Snacks market had total revenues of \$2,396.8m in 2021, representing a compound annual growth rate (CAGR) of 2.4% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 0.7% between 2016 and 2021, to reach a total of 173.6 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 0.8% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$2,494.6m by the end of 2026.
