The other hot drinks segment consists of chocolate-based hot drinks and malt-based hot drinks. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The Australian hot drinks market had total revenues of \$1,906.4m in 2021, representing a compound annual growth rate (CAGR) of 3% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 2.2% between 2016 and 2021, to reach a total of 71.2 million kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.4% for the five-year period 2021 2026, which is expected to drive the market to a value of \$2,479.4m by the end of 2026.
