All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The Italian hot drinks market had total revenues of \$3,690.8m in 2021, representing a compound annual growth rate (CAGR) of 4.6% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 2.7% between 2016 and 2021, to reach a total of 238.9 million kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$4,714.9m by the end of 2026.
