- The Dutch Savory Snacks market had total revenues of \$1,262.0m in 2021, representing a compound annual growth rate (CAGR) of 2.9% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 1.5% between 2016 and 2021, to reach a total of 137.4 million kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.6% for the five-year period 2021 2026, which is expected to drive the market to a value of \$1,507.5m by the end of 2026.
