All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The UK hot drinks market had total revenues of \$4,213.7m in 2021, representing a compound annual growth rate (CAGR) of 6.8% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 2.8% between 2016 and 2021, to reach a total of 223.6 million kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 7.8% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$6,132.3m by the end of 2026.
