- The UK Soups market had total revenues of \$1,101.7m in 2021, representing a compound annual growth rate (CAGR) of 1.4% between 2016 and 2021.
- Market consumption volumes declined with a CAGR of -0.4% between 2016 and 2021, to reach a total of 205 million kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 1.8% for the five-year period 2021 2026, which is expected to drive the market to a value of \$1,206.1m by the end of 2026.
