- The Turkish Soups market had total revenues of \$81.6m in 2021, representing a compound annual growth rate (CAGR) of 9.3% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 6% between 2016 and 2021, to reach a total of 19.2 million kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 11.8% for the five-year period 2021 2026, which is expected to drive the market to a value of \$142.7m by the end of 2026.
