- The life reinsurance segment was the market's most lucrative in 2021, with total ceded premiums of \$320.3 billion, equivalent to 53.1% of the market's overall value.
- The market decelerated to very weak growth in 2020, partly due to the implications of the COVID-19 pandemic. However, 2021 saw a strong rebound as the market returned to a relative normality.
