- China is expected to lead the apparel & non-apparel manufacturing industry in the BRIC nations with a value of \$506,969.3 million in 2026, followed by India, Brazil, Russia with expected values of \$85,328.3, \$25,307.4 and \$10,524.4 million, respectively.
