- Within the apparel & non-apparel manufacturing industry, China is the leading country among the top 5 emerging nations, with market revenues of \$391,418.5 million in 2021. This was followed by India and Brazil with a value of \$64,380.2 and \$21,393.2 million, respectively.
- China is expected to lead the apparel & non-apparel manufacturing industry in the top five emerging nations, with a value of \$506,969.3 million in 2026, followed by India and Brazil with expected values of \$85,328.3 and \$25,307.4 million, respectively.
