This can be seen as a continuation of the strong performance recorded in the category in 2021 after registering stagnant growth in 2020 at the peak of the COVID-19 pandemic, although sales growth slowed down somewhat in 2022. The main reason for such a strong performance in other dairy was strong consumer demand...
