Prices in Israel continue to rise, and raw milk prices have increased, which has led the government to increase the cost cap on many price-controlled products. However, this strategy has not always worked in the past. After cottage cheese was removed from its price controls in 2011, locals protested and boycotted cottage cheese until the prices came down. Locals are very price-sensitive regarding basic dairy products and, within this environment, brands find it challenging to increase their prices.
