#### Market Overview

The demand for manhole covers and grating is growing significantly in the North American market owing to Growing government initiatives to strengthen civic systems and Rising construction activities. A manhole cover is a removable plate that forms a lid over the opening of a manhole to prevent anyone or anything from falling in and keep out unauthorized persons and material. Manhole covers come in different sizes and shapes and are often made from cast iron, composites, or fabricated steel. A grating is a framework of parallel or crossed bars, typically preventing access through an opening while permitting communication or ventilation.

The North America manhole cover and grating market is projected to grow at a 4.9% CAGR during the forecast period, 2021-2027. In 2020, the manhole cover and the grating market were dominated by the US with a 52.2% share, followed by Canada & Mexico with shares of 26.8% and 21.1%, respectively. The growth of the North America manhole covers, and grating market is expected to be driven by factors such as the growing government initiatives to strengthen the civic systems and the rising construction activities. However, the fluctuation in raw material prices and the increased import of manhole covers are likely to restrain the growth of the manhole covers and grating market. Nevertheless, innovation in manhole cover designs is expected to present lucrative growth opportunities for the vendors in the North American market.

SSOs can contaminate water sources, causing serious water quality problems and property damage and threatening public health.
