The Mexico was the fastest growing country, with a CAGR of 2.8% over the 2017-21 period.
- Within the paper & paperboard industry, the US is the leading country among the NAFTA bloc, with market revenues of \$64,760.6 million in 2021. This was followed by Mexico and Canada, with a value of \$10,224.1 and \$6,005.1 million, respectively.
- The US is expected to lead the paper & paperboard industry in the NAFTA bloc, with a value of \$72,067.9 million in 2026, followed by Mexico and Canada with expected values of \$13,780.0 and \$6,772.0 million, respectively.
