- Within the paper & paperboard industry, China is the leading country among the BRIC nations with market revenues of \$104,916.0 million in 2021. This was followed by India, Brazil and Russia with a value of \$12,947.7, \$10,680.5, and \$7,421.8 million, respectively.
- China is expected to lead the paper & paperboard industry in the BRIC nations with a value of \$113,575.2 million in 2026, followed by India, Brazil, Russia with expected values of \$16,036.0, \$13,149.7 and \$12,033.0 million, respectively.
