### Summary

- The paper and paperboard market measures a country's or region's total use of paper and paperboard. Paper and paperboard include newsprint, printing and writing paper, packaging paper, household and sanitary paper, and other paper and paperboard. Volumes represent the consumption of paper and paperboard in tonnes, and values are calculated using average annual selling price of paper and paperboard per tonne multiplied by consumption volumes. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Singaporean paper and paperboard market had total revenues of \$0.4 billion in 2021, representing a compound annual growth rate (CAGR) of 0.3% between 2016 and 2021.
- Market consumption volumes declined with a CARC of -16% between 2016 and 2021, to reach a total of 0.3 billion units in 2021.
- The value of the Singapore paper and paperboard market witnessed declining growth of 5.8% owing to the recessionary impact of the COVID-19 pandemic.
