Volumes represent the consumption of paper and paperboard in tonnes, and values are calculated using average annual selling price of paper and paperboard per tonne multiplied by consumption volumes. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The South Korean paper and paperboard market had total revenues of \$10.2 billion in 2021, representing a compound annual growth rate (CAGR) of 3.3% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 3.2% between 2016 and 2021, to reach a total of 10.6 billion units in 2021.
- The value of the South Korean paper and paperboard market witnessed strong growth by 2.2% in 2021 with the real GDP growth rate of South Korea expanded by 4.0% in 2021 according to GlobalData estimates.
