- Foodservice is defined as the value of all food and drink, including on-trade drinks not drunk with food, for immediate consumption on the premises or in designated eating areas shared with other foodservice operators, or in the case of takeaway transactions, freshly prepared food for immediate consumption. Foodservice is restricted to the sale of food and drink in specific foodservice channels defined below and excludes vending machines.
- The Russian foodservice industry had total revenues of \$10.2bn in 2021, representing a compound annual growth rate (CAGR) of -3.5% between 2016 and 2021.
- Industry consumption volumes declined with a CAGR of -2.2% between 2016 and 2021, to reach a total of 2.5 billion transactions in 2021.
- Growth in the Russian foodservice industry has been very unequal regionally. Major cities have a greater variety and larger number of foodservice outlets to target more affluent urban dwellers.
