- Foodservice is defined as the value of all food and drink, including on-trade drinks not drunk with food, for immediate consumption on the premises or in designated eating areas shared with other foodservice operators, or in the case of takeaway transactions, freshly prepared food for immediate consumption. Foodservice is restricted to the sale of food and drink in specific foodservice channels defined below and excludes vending machines.
- The German foodservice industry had total revenues of \$86.4 billion in 2021, representing a compound annual growth rate (CAGR) of -3.7% between 2016 and 2021.
- Industry consumption volumes declined with a CAGR of -3.7% between 2016 and 2021, to reach a total of 8.4 billion transactions in 2021.
- Germany has strong economic position in the European continent with high level of employment. However, the COVID-19 pandemic impacted the economic growth of the country and thereby impacting the foodservice industry.
