Foodservice is restricted to the sale of food and drink in specific foodservice channels defined below and excludes vending machines.
- The Italian foodservice industry had total revenues of \$111.6 billion in 2021, representing a compound annual growth rate (CAGR) of -4.1% between 2016 and 2021.
- Industry consumption volumes declined with a CAGR of -4.5% between 2016 and 2021, to reach a total of 13.9 billion transactions in 2021.
- In 2021, the Italian foodservice industry recorded strong growth primarily due to the strong recovery of economic activities as the Italian government eased COVID-19 restrictions.
