For the second successive year, car sales in Spain were impacted by the post-COVID-19 economic crisis. However, both the electric car and shared mobility segments have maintained solid growth rates. Plug-in hybrid electric vehicles (+86% year on year) and shared scooters (+59% year on year) have boomed in 2021, the former sustained by state-funded scrapping schemes, the latter by consumers' preference for non-contact mobility.
