During the review period prior to the onset of COVID-19, retail constant value sales (2022 prices) exhibited dynamic growth, but pandemic restrictions saw them plunge by almost a third in 2020, and this decline continued into 2021-albeit at a much more modest rate. With COVID-19 restrictions substantially eased and gyms operating normally again, demand began to rebound in 2022 but retail constant value sales remained well below their p...
