Overall, the picture was bleak for tobacco in Estonia in 2021, with a fall in current value sales, largely driven by a sizeable drop in volume sales of cigarettes. Several factors led to the volume drop in cigarettes. More people gave up smoking completely, due to health concerns. In addition, there was an increase in excise duty and this was coupled with rising inflation, as increasing energy costs pushed up overall retail prices and these push points made cigarettes less affordable and some co...
