After two years of severe COVID-19 travel restrictions, inbound arrivals to Ireland more than doubled during 2022 but remained well below their pre-pandemic level. During July 2022, monthly international tourist visits to Ireland were 11% lower than in July 2019 (at just over one million), according to trade group the Irish Tourism Industry Confederation (ITIC).
