After two years of severe COVID-19 travel restrictions, inbound arrivals to Ireland more than doubled during 2022 but remained well below their pre-pandemic level. COVID-19 restrictions on travel were largely eliminated early in the year: International travellers arriving in Ireland no longer had to carry evidence of their vaccination status (as they did in 2021) or proof that they have recovered from the virus.
