### **Report description:**

Chile witnessed a significant rebound in consumer credit gross lending in 2021 following the previous year's drop. However, the value of some lending categories remained below pre-pandemic levels. This was mainly due to joint support measures introduced by the government (subsidies and direct transfers to the most financially-stretched households, in addition to permission to make three consecutive 10% withdrawals from pension funds), and the Central Bank (expansive monetary policy).
