During March 2022, the Bank of Israel announced that interest rates would be rising for the first time since 2018. This led to March 2022 broken all records for the numbers of mortgages being taken out in the country, with NIS13 billion in mortgage loans extended during the month. In April, the Bank of Israel increased interest rates by 0.25 points to 0.35%, and in May 2022 interest rates were increased again by 0.4 points, reaching 0.75%. In July 2022, the Bank of Israel again increased interes...
