The Norwegian economy showed a faster recovery than many other European countries at the end of the review period. As the Coronavirus (COVID-19) public health crisis and related restrictions and measures eased, unemployment decreased and consumers shifted back towards pre-pandemic lifestyles. This increased the number of applications for new loans in 2022. This growth was most visible in card lending, but non-card lending also performed well in this regard.
