Cooking ingredients and meals is witnessing a second year of decline in retail volume growth in 2022, due to the weak performance of the edible oils category. Inflationary pressure and a reduction of imports from major producing countries such as Russia and Ukraine has negatively affected consumption of edible oils, pushing retail volume sales of cooking ingredients and meals into decline. However, current value growth has reached a new double-digit high as a result of the price increases.
