The price points of edible oils has increased rapidly in 2022, due to limited supply causing increased demand. Supply bottlenecks of sunflower oil, following Russia's invasion of Ukraine, and of palm oil, are two factors contributing to this dynamic. These increasing unit prices have resulted in very high double-digit current retail value sales; however, it has forced many consumers to reduce their purchases or stop using edible oil altogether, shifting to alternative products and methods.
