The global smart parcel locker market is estimated to witness a strong growth rate of more than 12% during the forecast period. A smart parcel locker is a self-directed ampoule technology used for storing and delivering parcels and packages. A smart parcel locker is also called a smart integrated lock which is a popular and intriguing alternative to a well-traveled delivery system. Rapid growth in online shopping and & E-commerce, technology upgradation, and increasing focus on providing optimum solutions to customers are some of the key factors expected to boost the demand for smart parcel lockers across the globe. Moreover, contactless delivery, complete chain of custody, 24/7 self-service access, prompt delivery, and installation are some of the benefits which are anticipated to further propel the demand for the adoption of smart parcel lockers globally. However, limited locker capacities are one of the major challenges faced by the global smart parcel locker market.

#### Market Segmentation

The global smart parcel market has been segmented on the basis of type, application, and region. Based on type the market is segmented into modular parcel locker, cooling locker, postal locker, laundry locker, and others (Self-service parcel locker). On the basis of application, the market is segmented into Retail, Government Agencies (Post offices), Colleges and Universities, Public Enterprises and Commercial Buildings, and others (Residential, etc.). On the basis of Deployment, the market is divided into Indoor and Outdoor. Geographically the market is segmented into North America, Latin America, Western Europe, Eastern Europe, Asia Pacific, and MEA. North America is dominating the global smart parcel locker market.
