- The French Electricity Retailing market had total revenues of \$83.8bn in 2021, representing a compound annual growth rate (CAGR) of 3.1% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 1.8% between 2016 and 2021, to reach a total of 474.2 TWh in 2021.
- The market's decline in 2020 can be largely attributed to the COVID-19 pandemic which greatly inhibited consumer and business activity through lockdown measures.
