The "other" segment includes agriculture, forestry, and the fishing industry's net electricity consumption among others.
- The German Electricity Retailing market had total revenues of \$171.9bn in 2021, representing a compound annual growth rate (CAGR) of 1.6% between 2016 and 2021.
- Market consumption volumes declined with a CAGR of -0.1% between 2016 and 2021, to reach a total of 542.1 TWh in 2021.
- Residential energy consumption may have increased due to an increase in work-from-home activity and consumers spending more time indoors but the strength of industry in Germany meant it remained the largest segment.
