Summary

Marine Freight in Italy industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-21, and forecast to 2026). Key Highlights

- The marine freight sector is defined as consisting of revenues generated from freight transportation by ship of container (only LoLo) and dry bulk cargo, by sea- and ocean-going vessels. The sector includes both domestic and international freight, which for the purposes of this report is counted in the country of origin. The values are calculated by multiplying the average price of the goods per ton of volume of cargo transported. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Italian marine freight industry had total revenues of \$13.7 billion in 2021, representing a compound annual growth rate (CAGR) of 7.6% between 2016 and 2021.
- The containerized segment was the industry's most lucrative in 2021, with total revenues of \$9.4 billion, equivalent to 68.7% of the industry's overall value.
- A boom in growth in the Italian marine freight sector in 2021 has been bolstered by pent up consumer demand for commodities such as clothing, toys, and automobiles.
