- The Spanish internet access market had total revenues of \$5,225.3 million in 2021, representing a compound annual growth rate (CAGR) of 2.6% between 2016 and 2021.
- Market volume increased with a CAGR of 2.6% between 2016 and 2021, to reach a total of 43 million internet users in 2021.
- With lockdown measures keeping people at home, residential demand for faster internet and multi-play packages that include digital media entertainment increased, driving growth for the market in 2020 and into 2021.
