- The Turkish internet access market had total revenues of \$2,018.0 million in 2021, representing a compound annual growth rate (CAGR) of 0.4% between 2016 and 2021.
- Market volume increased with a CAGR of 11.2% between 2016 and 2021, to reach a total of 66.9 million internet users in 2021.
- Growth in the Turkish market in recent years has been fueled both by increased investment in infrastructure and networks supporting wireless connectivity, and the rising popularity of smartphones.
