- The internet access sector consists of the total Internet Service Revenue charged for the provision of narrowband and broadband Internet connections through both consumer and corporate channels. All revenues calculated are retail revenues exclusive of taxes. Only fixed communication is included; mobile connections are not considered.
- The European internet access market had total revenues of \$75,444.3 million in 2021, representing a compound annual growth rate (CAGR) of 3.8% between 2016 and 2021.
- Market volume increased with a CAGR of 2.7% between 2016 and 2021, to reach a total of 595 million internet users in 2021.
- The western European markets of France, Germany, and the UK contributed the most to the overall regional market's value. In 2021, the UK generated 21.9% of the revenues in this market, while France and Germany accounted for 15.3% and 17.7%, respectively.
