After a dynamic performance in 2021, off-trade demand for carbonates remains elevated in 2022 compared to pre-pandemic levels, despite a marginal drop over the year. Signs of moderation after the boom are being driven by the end of government aid in Chile, and therefore the gradual waning effect of excess liquidity in the local economy, along with rising inflation, is placing pressure on disposable incomes.
