- Among the G8 nations, the US is the leading country in the movies & entertainment industry, with market revenues of \$18,562.0 million in 2021. This was followed by Japan and Germany, with a value of \$3,685.8 and \$2,377.5 million, respectively.
- The US is expected to lead the movies & entertainment industry in the G8 nations with a value of \$26,301.4 million in 2016, followed by Japan and the UK with expected values of \$3,062.2 and \$2,969.3 million, respectively.
