- Within the movies & entertainment industry, China is the leading country among the BRIC nations with market revenues of \$6,798.5 million in 2021. This was followed by Russia, Brazil and India with a value of \$606.5, \$341.6, and \$233.2 million, respectively.
- China is expected to lead the movies & entertainment industry in the BRIC nations with a value of \$8,682.8 million in 2026, followed by Russia, Brazil, India with expected values of \$1,019.9, \$723.5 and \$633.6 million, respectively.
