- Within the aerospace & defense industry, China is the leading country among the BRIC nations with market revenues of \$39,601.8 million in 2021. This was followed by Russia, India and Brazil with a value of \$34,885.1, \$21,813.2, and \$3,929.9 million, respectively.
- China is expected to lead the aerospace & defense industry in the BRIC nations with a value of \$53,570.5 million in 2026, followed by Russia, India, Brazil with expected values of \$32,481.2, \$23,024.1 and \$3,670.7 million, respectively.
