- Within the ice cream industry, the US is the leading country among the NAFTA bloc, with market revenues of \$13,355.9 million in 2021. This was followed by Canada and Mexico, with a value of \$754.1 and \$549.9 million, respectively.
- The US is expected to lead the ice cream industry in the NAFTA bloc, with a value of \$15,570.2 million in 2026, followed by Canada and Mexico with expected values of \$871.4 and \$784.5 million, respectively.
