- Within the ice cream industry, China is the leading country among the top 5 emerging nations, with market revenues of \$8,073.8 million in 2021. This was followed by India and Brazil with a value of \$2,164.8 and \$1,841.7 million, respectively.
- China is expected to lead the ice cream industry in the top five emerging nations, with a value of \$9,722.0 million in 2026, followed by India and Brazil with expected values of \$3,548.8 and \$2,965.8 million, respectively.
