- Market consumption volumes declined with a CAGR of -0.6% between 2016 and 2021, to reach a total of 1,175.1 million kilogram in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$52,907.3m by the end of 2026.
