In 2022, coffee continued to underperform for the third consecutive year, although to a lesser extent than across the review period. This modest performance is mainly due to its high price, partnered with declining disposable incomes in the country. This has led to a rise in price-conscious behaviour, with some consumers opting for cheaper green tea as a substitute.
