The COVID-19 pandemic resulted in a steep decline in non-alcohol beer sales in 2020, particularly in the on-trade. Moreover, the economic effects of the pandemic saw the Saudi Arabian Government raise VAT from 5% to 15% in July 2020. Furthermore, in June 2020, the government terminated a monthly cost-of-living stipend paid to government employees. All these measures...
