The strict lockdown in spring 2020 in Spain due to the COVID-19 outbreak required the closure of all on-trade establishments, which had a major impact on volume sales of alcoholic drinks and its packaging in the on-trade in 2020 as a whole. This was further exacerbated by the drop in inbound tourism over the summer, with the on-trade losing almost a third of its unit volumes in 2020. Alcoholic drinks consumption shifted from bars and restaurants into people's homes, driving off-trade volume sale...
