Gum packaging, which was already in decline in 2019, recorded a steep fall in 2020, when the pandemic resulted in a major reduction in impulse purchasing and on-the-go consumption. This was still ongoing to an extent in 2021, when gum recorded another double-digit percentage decline in its unit volumes. Flexible packaging, mainly flexible aluminium/paper, but also some flexible plastic and blister and strip packs, is the dominant pack type for gum, with other rigid containers growing in importan...
