Retail volume sales of gum saw modest growth in 2022, following declines in the previous two years. As restrictions on mobility were eased and consumers began to return their offices, they resumed purchasing chewing gum for its breath-freshening properties. However, mask-wearing restrictions remained in place for essential shops and public transport until June 2022, which restricted sales to some extent.
